



Waiver and Release

In consideration for SEVillage, LLC (the "Organization") and The Human Hacking Conference (the "Conference") allowing me and/or my child(ren) to attend and participate in the Conference:

I, ON BEHALF OF MYSELF AND MY CHILD(REN), ACKNOWLEDGE THAT BY SIGNING THIS CONTRACT, I AM SOLELY RESPONSIBLE FOR ALL INJURIES, ILLNESSES, DEATH, LOSSES, OR DAMAGES, **INCLUDING THOSE ASSOCIATED WITH AND/OR ARISING FROM THE CORONAVIRUS/COVID-19**, THAT I, MY CHILDREN, OR THOSE IN MY CARE OR CUSTODY MAY SUFFER OR INCUR IN CONNECTION WITH THE CONFERENCE OR ANY FUTURE PROGRAM OR EVENT ASSOCIATED WITH THE ORGANIZATION.

I, ON BEHALF OF MYSELF AND MY CHILD(REN), FURTHER AGREE TO INDEMNIFY, TO HOLD HARMLESS, AND NOT TO SUE THE ORGANIZATION, THE CONFERENCE, SOCIAL-ENGINEER, LLC AND ANY OF THEIR RESPECTIVE AFFILIATES, MEMBERS, OWNERS, OFFICERS, EMPLOYEES, CONTRACTORS, MANAGERS, REPRESENTATIVES, AGENTS, PRESENTERS, VOLUNTEERS, SPONSORS, EVENT DIRECTORS, AND ORGANIZERS (COLLECTIVELY "RELEASEES") FOR ANY INJURIES, ILLNESS, DEATH (**INCLUDING THOSE ASSOCIATED WITH AND/OR ARISING FROM OR CAUSED BY THE CORONAVIRUS/COVID-19**), LOSSES, OR DAMAGES THAT I AND/OR MY CHILD(REN) MAY SUFFER OR INCUR.

I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS ON BEHALF OF MYSELF AND MY CHILD(REN). THIS DOCUMENT IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES AND IT APPLIES TO ALL ACTIVITIES AT THE CONFERENCE. I HAVE READ IT CAREFULLY BEFORE SIGNING, AND I UNDERSTAND WHAT IT MEANS AND WHAT I AM AGREEING TO BY SIGNING.

On behalf of myself and my children, heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors"), I hereby **waive, release, discharge and agree to indemnify, defend, and hold harmless and not to sue** the Releasees from all claims, causes of action, damages, losses (economic and non-economic), and liabilities of every kind in law, equity, or otherwise, known or unknown, suspected or unsuspected, disclosed or undisclosed, for any and all causes of action, claims, demands, damages, losses, liabilities, costs and expenses, actual or consequential, past, present and future, for personal injury, illness, disability, death, property damage, including but not limited to attorneys' fees and litigation expenses (each a "Claim"), arising out of or resulting from, directly or indirectly, in whole or in part, that are in any way connected with or related to the Conference, the Releasees, and/or any actions taken by or any failure to act by the Releasees, even if caused by negligence, to the maximum extent permitted by law. I further acknowledge I have reviewed and evaluated the risks and have voluntarily determined to bring myself, and/or my child(ren), to the Conference with full knowledge and acceptance of the risks.

I, on behalf of myself and my Successors, agree not to make any Claim relating to the Conference, or which may arise out of, result from, or relate to my participation in, accommodation at, or me or my child(ren) traveling to or from the Conference.

I, on behalf of myself and my Successors, agree it is my sole responsibility to be familiar with the Conference and the Releasees' rules, and any special regulations for the Conference and agree to comply with all such rules and regulations. I understand and agree that situations may arise during the Conference which may be beyond the control of Releasees, and I and my child(ren) must participate so as to neither endanger myself, my child(ren) or others. Neither I nor my child(ren) have any physical or medical condition which would endanger myself, my child(ren) or others if I/they participate in the Conference, or would interfere with my or my child(ren)'s ability to safely participate in the Conference.

I understand that the Organization does not provide insurance coverage or any care whatsoever for accidents or injury sustained by myself or my child(ren). I agree that the attendance by me and/or my child(ren) at the Conference and participation in activities or events at the Conference shall be undertaken by me and/or my child(ren), at our sole risk, and the Organization shall not be liable in any way for any Claims or damages whatsoever to me and/or my child(ren), irrespective of cause or origin. The Organization shall not be responsible or liable for articles damaged, lost, or stolen, in or about the Conference, or for loss or damages to any personal property or belongings.

Coronavirus/Covid-19 Acknowledgement and Requirements

The Coronavirus/COVID-19, has been declared a worldwide pandemic by the World Health Organization and the United States Center for Disease Control ("CDC"). Coronavirus/COVID-19 is extremely contagious. As a result, federal, state, and local governments and federal and state health agencies have recommended, and in certain instances mandated, certain cautions and controls be taken, including, but not limited to wearing masks, facial coverings, and other personal protective equipment, practicing social distancing, and avoiding or prohibiting the congregation of groups of people.

I, on behalf of myself and my Successors, agree and acknowledge that the Releasees cannot guarantee that I and/or my child(ren) will not become infected with the Coronavirus/Covid-19 if I and/or my child(ren) attend the Conference. I understand, acknowledge and agree that my and my child(ren)'s risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 will increase by my and my child(ren)'s attendance at the Conference, and that this risk may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the Releasees, and that **this Waiver and Release applies to any and all Claims relating to Coronavirus/COVID-19 and the Releasees.**

I, on behalf of myself and my Successors, acknowledge and agree that I and/or my child(ren) are voluntarily attending the Conference and that I/we must comply with all set rules, policies and procedures to reduce the spread Coronavirus/COVID-19 while attending the Conference, including, but not limited to, confirming and attesting that:

- Neither I nor any of my child(ren) are experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- Neither I nor any of my child(ren) have traveled internationally within the last 14 days.
- Neither I nor any of my child(ren) have traveled to a highly impacted area within the United States of America in the last 14 days.
- Neither I nor any of my child(ren) believe that I/we have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- Neither I nor any of my child(ren) have tested positive for or been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- I and any of my child(ren) are following all CDC recommended guidelines and have limited my/our exposure to the Coronavirus/COVID-19.

I HEREBY ATTEST THAT I HAVE 1) READ AND UNDERSTAND THE ABOVE WAIVER AND RELEASE AND 2) THAT I HAVE RECEIVED, READ, AND UNDERSTAND THE ORGANIZATION'S RULES, REGULATIONS, POLICIES AND PROCEDURES GOVERNING ATTENDANCE AT THE CONFERENCE.

I further agree, for myself and my Successors, that the above representations, acknowledgements and agreements are contractually binding, and are not mere recitals, and that should I or my Successors assert a Claim contrary to what I have agreed to in this contract, the claiming party shall be liable for all expenses (including legal fees) incurred by Releasees in defending the Claims. This contract may not be modified orally, and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision herein or as consent to any other waiver or modification. I consent to the release by any third party to Releasees and their insurance carriers of my and/or my child(ren)'s name and medical information that may relate solely to any injury or death I and/or my child(ren) may suffer arising from the Conference. Every term and provision of this contract is intended to be severable. If any one or more of

them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

In the event that I and/or my child(ren) are unable to do so because of an injury, I consent to administration of first aid and other medical treatment in the event of injury and agree to pay the costs of any such treatment.

Photographic Release: I, for myself and my child(ren) grant and convey to the Releasees all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my child(ren)'s likeness or voice made by the Conference and/or the Releasees.
